

## CAR PARKING RULES

### 1. Purpose

These Rules, as amended from time to time by the Board, are to provide members and management with clear directions on the use of DSS motor vehicle parking facilities on the DSS property.

These Rules reflect the intent of the Board on the provision of services to members.

### 2. Background

The DSS parking facilities provides the opportunity for members, member guests and legitimate visitors of the club to park their motor vehicles at the club when they are utilizing its services and facilities.

The DSS has significantly more members than available vehicle parking spaces meaning that there are times where vehicle parking demand cannot meet vehicle parking supply. The DSS therefore needs to have appropriate rules and policies to manage the scarce resource.

### 3. Scope

These rules apply to the all areas of the DSS property.

### 4. Rules

#### 4.1. General

- a. Members, member guests and legitimate visitors to the Club may park their car at the Club only when visiting the Club to use its facilities, marine services and/or social and training facilities.
  - A legitimate visitor to the club is defined as someone who is not a member or a guest of a member:
    - Is using the Clubs Food and Beverage services;
    - Is attending an organised function;
    - Is attending a Club conducted training course;
    - Is utilising marine facilities or service facilities under a casual contract.
- b. Members must display their member car sticker on the windscreen of their car.
- c. Member guests and legitimate visitors to the club must sign in the book provided and note their registration number.
- d. Cars must be parked within the defined lines of the Car Park.
- e. Only standard vehicles may park in the car-park and no trailers are allowed in a car space.
- f. Parking is not permitted in the following areas:
  - driveways or at the main entrance to the Clubhouse;
  - in areas where no parking is specified;
  - in areas reserved for Flag Officers, Board Members, staff or tenants;

- within the trailer parking areas;
  - within the boat service yard;
- g. The Car Park may not be used as a long-term car park, for example when they are away on an extended cruise of greater than 7 days or are living aboard their boat. For long-term parking members should use the alternative car-park described below.
- h. The Car Park may not be used as a short-term car park, for example to attend employment elsewhere or to attend university.
- i. Disabled Parking: There are two car parking spaces available for members or visitors who hold a valid disabled parking permit on a first-come, first-served basis.
- j. Members are permitted only a single vehicle in the car park at any given time.
- k. The Club accepts no responsibility regarding the security or damage to motor vehicles using the Car Park. Members, member guests and legitimate visitors do so at their own risk.
- l. Members failing to comply with these rules may be referred to the Board for disciplinary action;
- m. Non-members failing to comply with these rules may be subject to a legal claim by the club for liquidated damages for unauthorised use of a private car-park. (refer following notice).

#### 4.2. Alternate Parking Options

There are alternate parking areas available in the vicinity of the DSS including:

- a. Unmetered street parking along Marieville Esplanade;
- b. The Hobart City Council parking area situated south of the DSS Boat Service Yard.
