SAILING INSTRUCTIONS

2 March 2024

Organising Authority:





The notation [NP] in a rule of the Saiing Instructions (SI) means that a boat may not protest another boat for breaking the rule. This changes Racing Rules of Sailing (RRS) 60.1(a).

The notation [DP] in a rule of the SI means that a penalty for a breach of the rule may, at the discretion of the protest committee, be less than disqualification. This changes RRS 64.1.

- 1. RULES
 - 1.1. The race will be governed by the rules as defined in the Racing Rules of Sailing 2021-2024 (RRS) of World Sailing, except as amended by this SI and/or Notice of Races Notice (NoR)
 - 1.2. The race will be governed by the current versions of:
 - a. the IRC Rules 2023 Parts A, B and C;
 - b. the IMS Rule and ORC Rating System Rules 2023; and
 - c. the prescriptions and special regulations of Australian Sailing (AS Special Regulations), a copy of which is found at https://www.sailingresources.org.au/safety/specialregs/. Where Australian Standards are specified in the AS Special Regulations equipment marked as satisfying a recognised equivalent international standard may be accepted.
 - 1.3. The Organising Authority (OA) may amend any detail of this SI before 17:00 on 26 February 2024
 - 1.4. CHANGES TO CLASS RULES AND RRS
 - a. RRS 52 is changed
 - i. to allow adjustment of movable ballast or canting keels on any boat and the use of stored power to do so and/or
 - ii. to allow the use of stored power for sail handling and sail trimming.
 - b. RRS 55.2 is changed to allow the use of fixed or retractable spinnaker poles and bowsprits for the purpose of setting spinnakers.
 - c. Appendix T Arbitration of the RRS applies.

2. OFFICIAL NOTICE BOARD

The Official Notice Board is a notice board situated in the window adjacent to the front entrance of the Derwent Sailing Squadron (DSS) in Sandy Bay. Notices posted on the Official Notice Board may also be published on the race website.



3. CHANGES TO SAILING INSTRUCTIONS

Changes to these SI, if any, shall be made in accordinate with RRS 90.2(c) and changes will be posted before 09:00 on the 2 March 2024, except that any change to the schedule of races will be posted by 20:00 on the 1 March 2024.

4. CODE OF CONDUCT [NP] [DP]

Competitors and support persons shall comply with reasonable requests from race officials.

5. SIGNALS MADE ASHORE

- 5.1. Signals made ashore will be displayed on the flagpole located to the east of the DSS clubhouse.
- 5.2. Flag AP, (Answering Pennant) with two (2) sound signals means 'the race is postponed'. The Warning Signal for that race will be made not less than 30 minutes after the AP, with one (1) sound signal, is removed.

6. SCHEDULE OF RACES

- 6.1. The Regatta will comprise of up to three (3) races.
- 6.2. No warning signal shall be made after 16:30 on Saturday 2 March 2024

8. DIVISION FLAGS

8.1. The division flags are:

9. RACE AREAS

Racing will be conducted on the waters of the River Derwent and Ralphs Bay.



10. COURSES

- 10.1. Courses to be sailed are detailed in Appendix A of the SI.
- 10.2. Boats shall not sail through the Start/Finish Line except when required to do by the SI or the RRS. A breach of this sailing Instruction shall be scored "Disqualified" (DSQ) without hearing.

11. MARKS

11.1. Marks of the course will be inflatable buoys or fixed marks as described in Appendix A of the SI.
The approximate location of the fixed marks to be used in passage races are noted in Appendix A of the SI.

12. START

12.1. Starting signals will be made in accordance with RRS 26 except as amended below:

ATTENTION SIGNAL – Ten (10) minutes before the start of the first Division a sound signal will be made.

- 12.2. The starting line will be between an orange staff or orange flag on the committee boat and a yellow with red band inflatable buoy.
- 13. CHANGE OF THE NEXT LEG OF THE COURSE
 - 13.1. To change the next leg of the course for courses 01 04 (as described in Appendix A) of the SI, the race committee will lay a new mark and remove the original mark as soon as practicable.
 - 13.2. The Mark 1 replacement will be a pink inflatable buoy.
 - 13.3. When in a subsquent change a new mark is replaced, it will be replaced by an original mark.
- 14. FINISH
 - 14.1. The finishing line will be between blue flag on the committee boat and a black and white chequered inflatable buoy. Boats shall finish from the course side.



15. SHORTENING COURSE

- 15.1. Any course may be shortened in accordance with RRS 32 except as amended below:
 - 15.1.1. If the race committee signals a shortened course (displays Flag S with two (2) sounds) for courses 01 04, as described in Appendix A of the SI, then a boat shall round/pass the mark as required and proceed directly to the finish.
 - 15.1.2. If the race committee signals a shortened course (displays Flag S with two (2) sounds) for courses 05 11, as described in Appendix A of the SI, then RRS 32.2 shall apply.

16. TIME LIMITS AND TARGET TIMES

- 16.1. The race time limit for courses 01-04, as described in Appendix A, shall be one (1) hour. Boats failing to finish within 20 minutes of the first finisher in that boat's division will be scored Did Not Finish (DNF). This changes RRS35.
- 16.2. The race time limit for courses 05 11, in Appendix A, shall be three (3) hours. Boats failing to finish within the time limit will be scored DNF. This changes RRS 35.

17. PENALTY SYSTEM

For courses 01-04, in Appendix A, RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

18. PROTESTS AND REQUESTS FOR REDRESS

- 18.1. For each division the protest time limit is 60 minutes after the last boat in that division finishes the last race of the day or after the race committee signals "no more racing today", whichever is later. The time limit for a protest or request for redress will be posted on the official notice board.
- 18.2. Notices will be posted no later than 30 minutes after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held in the DSS Board Room.

19. ARBITRATION

19.1. RRS Appendix T2 is deleted and replaced with:

An arbitration hearing may be offered prior to a protest hearing for an incident resulting in a protest by a boat involving one or more rules of Part 2 or Rule 31 of the RRS but only if

(a) both parties agree to arbitration, and



(b) each party is represented by a person who was on board at the time of the incident. No witness will be permitted. However, if the arbitrator decides that RRS 44.1(b) may apply or that arbitration is not appropriate the meeting will not be held and if a meeting is in progress it will be closed.

20. SCORING

- 20.1. For PHS this will be calculated by the application of a boats Time Correction Factor (TCF's) as a multiplier of elapsed time. A boat's TCF will be determined by the OA or its nominee. The determination of the TCF will not be subject to protest or redress (amends RRS 60.1 and 62.1(a) and RRS 63.1 shall not apply);
- 20.2. For IRC this will be the IRC Time Corrector (TCC) as printed on the certificate. For ORC this will be the Single Number Scoring Option, All Purpose (AP) Time on Time, as printed on the boat's rating certificate.
- 20.3. The Regatta will consist of a maximum of three (3) races with no discards.
- 21. PRIZES
 - 21.1. The overall divisional winners of the 2024 <u>Frontline Mind</u> DSS Women 42° South Women's *Regatta* will be calculated using the relevant Handicap System.
 - 21.2. Additional prizes may be awarded but the OA reserves the right to vary the number of prizes based on the number of entries as follows:
 - Three (3) five (5) entries 1st prize
 - Six (6) to nine (9) entries 1st & 2nd prizes
 - Ten (10) or more entries 1st, 2nd & 3rd prizes
- 22. SAFETY
 - 22.1. Boats shall comply with the AS Special Regulations Category 7 for the Regatta. A handheld VHF Radio shall be carried in the cockpit. This changes AS SR 3.25.1(b).
 - 22.2. For sports boats and boats without full lifelines, AS Special Regulations Part 1, Section 5, 5.01.1(j) (Lifejackets) shall apply.
 - 22.3. It is also recommended that entrants have a person overboard procedure that crew members have practised.



22.4. A boat that retires from a race shall notify the Race Committee as soon as practical.

23. RADIO COMMUNICATIONS

- 23.1. All race communication will be on VHF Channel 14
- 23.2. The Race Committee may broadcast the course to be sailed, names/sail numbers for OCS, UFD or BFD boats and/or other information of interest to competitors on VHF Channel 14. Any failure of or defect in such a broadcast will not be grounds for redress. This alters RRS 60.1 and 62.

24. DISCLAIMER

- 24.1. All those taking part in the race do so at their own risk and responsibility. By entering, crew members acknowledge that by doing so they release the OA, the race sponsor and any other sponsor of the Regatta and their respective officers, employees, volunteers and members from all liability and grant the rights referred to in NoR 18.
- 24.2. Specific attention is drawn to RRS Fundamental Rule 3 (Decision to race), which states: "The responsibility for a boat's decision to participate in a race or to continue racing is it's alone".

The Race Committee may use any of the courses for any of the races.

Mark W is specified as the first mark of the course after the start. This mark will be an orange inflatable buoy and will be laid approximately to windward at a distance of approximately 0.5 to 1.0 NM from the starting line. The direction of rounding the windward mark will be indicated on the Race Committee Signal Vessel – green flag for starboard rounding and red flag for port rounding. If no signal is made, this mark is deleted from the course.
